

Our team and specialist suppliers carried out comprehensive surveys and site visits during the pre-construction phase, verifying FRA reports, provisional sums and work specifications provided by the client. We developed designs which were approved by the client and building control. Additionally we employed:

- » Electrical design consultant
- » NICEIC qualified electrical subcontractor
- » UKAS accredited licensed asbestos removal subcontractor

Throughout the works we worked concurrently across the blocks. We prioritised completing the works to vulnerable residents homes.

## THE PROOF IS IN THE FIREPROOFING

After fire broke out at Drake House where Axis were conducting a programme of FRA works for our client Brentwood Borough Council Senior Contracts Manager Dan Wrigglesworth said:



We had replaced all the dwelling and communal doors in Drake House with FD30S fire doors. FD30S Fire Doors not only help to prevent the spread of fire, but also prevent the spread of cold smoke as the doors are fitted with cold smoke seals in addition to intumescent strips. It was evident from the communal side of the front door that both the smoke and intumescent seals had done their job as there was no evidence of smoke damage around the perimeter of the door or within the communal area itself.

That was really reassuring for us and for the client. We use fire resisting materials and systems that have been tested to ensure they will perform in the event of a fire, the systems need to be installed with the exact same methods in which they were tested and in this case they all performed exactly how they should have done...

What our works did was save the building and save lives. We protected the residents and kept them safe which is the overall goal.



## **L&Q FRA WORKS AND INTERNAL DECORATIONS**

Axis delivered Fire Risk Assessment Works for 200 homes at Lewisham Park Towers in Lewisham, south east London. During the works we de-canted and re-canted 400 residents.

The scope of works here includes the installation of Sprinkler System and general Fire Safety upgrade works as well as communal electrical upgrades and the replacement of boilers and flues. Residents were decanted whilst the sprinkler systems and boilers were installed in their homes.

The works also saw internal and external decorations including removal of polymer coatings.


Our contract saw essential external fire safety works carried out at six 21-storey tower blocks, each housing 125 apartments. Works included the replacement of combustible timber balcony decking with new Bauder waterproofing as well as the installation of new external wall insulation (EWI). Internally, we installed fire alarms and AOV systems alongside replacing non-compliant steel fire doors with fully compliant timber fire doors.
